## **TO ALL IAMAW MEMBERS AT AIR CANADA**

### **EMPLOYEE PARKING TAXABLE BENEFIT**

Dear Brothers and Sisters:

The company informed the Union in mid August that they were in an argument with the Canada Revenue Agency (CRA) that parking facilities provided by Air Canada to its employees is a taxable benefit. This includes parking at Airports, Cargo and Maintenance facilities. The CRA ruling provides that any Canadian based employee who has access to a company provided parking space must have the value of this parking availability assessed as a taxable benefit. The Union immediately requested that the company advise the membership of this situation and to supply Transportation District 140 with all the pertinent information in order that we could have our membership get involved with their MP to help stop this taxation, this did not occur.

Transportation District 140 is trying to get all the information that we can to keep our membership informed of the situation. Until we have the information please see your MANAGER if you have any questions on this issue.

We are also requesting that you see your MP and advise them of your negative stance to this new taxation law.

We are also in the process of having a simple point and click letter to your MP located on the District 140 website ([www.iam140.ca](http://www.iam140.ca)).
